



## Are You a Registered Migration Agent?

With the major overhaul of the Migration Regulations on General Skilled Migration (GSM) visas that took effect from 1 July 2010 and the policy changes of over 35 skills assessing authorities that took effect on or after that date, it has become imperative for us, as registered migration agents to spend a lot of time in research work to keep our knowledge up-to-date.

As registered migration agents, we have a social and ethical responsibility to ensure that our advice on the prospects of a client's success or failure in obtaining suitable skills assessment and on visa approval is based on the latest skills assessment policy guidelines and the most recent changes to the Migration Regulations. - Registration with overseas registration boards, if required;
- Theoretical, practical or clinical examinations, if required;
- Minimum English skills required;
- Skills assessment fees.
